

# **Conditions of participation**

**The number of participants is limited. We therefore recommend you register in good time!**

**Your registration becomes valid when you receive the confirmation of registration from us by e-mail.**

**Until then, your registration is only considered a reservation!**

## **Reservation / Registration, Confirmation**

We check all the reservations we receive and send you a confirmation of receipt. If you do not receive this confirmation within one week, please contact us again in case your initial reservation never reached us.

For minors under the age of 18 years, the registration requires the signature of a parent or guardian. Registration of children under 12 years is only possible if the parent or guardian has first contacted the Fiddle & Feet School of Dancing personally.

## **Payment conditions**

As we have a soft spot for dancers and trust in the fairness and honesty of Irish dancers, we have agreed with Colin that the workshop fee should be paid in cash at the beginning of the workshop. However, please note that for registrations received after 25.04.2012 fees are higher!

## **Cancellation of registration**

If you have completed your registration but want or have to cancel your registration, we feel that is almost punishment enough... so if the cancellation is received by 25.04.2012 only 50% of the workshop fee is due. Unfortunately, after this time the whole workshop fee must be paid – unless you name a replacement participant, in which case the cancellation is free. If you are not able to offer a replacement yourself, we will try to find one from the waiting list. If we succeed, only a processing fee of € 10.00 is due. Please note that we only offer this as an option and are not able to guarantee actually finding another participant to take your place!

## **Waiting list**

If all places in the course have already been reserved when we receive your registration, we will of course notify you and you will automatically be placed on the waiting list. As soon as a registered dancer cancels, the next person on the waiting list will have the opportunity to take their place.

## **All rights reserved**

Naturally, we will inform all registered participants immediately if there are any changes to the booked workshop. Every participant is therefore responsible for ensuring that the e-mail address used in the registration is current and active.

Please note that course times or the location may also change. We reserve the right to switch participants to a different course level if necessary. It is also possible that the workshop may last longer than planned. Please take account of this when planning your return journey.

## **Drinks, food and accommodation**

The workshop fee only covers the actual workshop.

Participants must organise and pay for their own food, drinks and accommodation.

## **Filming & photography, spectators**

- Filming and photography (or other recordings) are not permitted during the workshop or during the breaks.
- Spectators are not permitted during the workshop, unless they have paid the full course fee like the other participants.

## **Other matters**

- The workshop language is English.
- The instructions of the trainer or the organiser must be followed at all times.
- In the interests of all participants, we request that you arrive punctually for the workshop.  
If this should not prove possible, please join the group in a way that causes the minimum disruption to the course.
- The organisers accept no liability for the loss of valuables.
- Participation in this workshop is at the participant's own risk. The organiser and trainer are only liable for injuries or damage caused by intent or negligence.
- If one of these conditions of participation should be legally invalid, the other conditions still apply.
